Premier Holidays have recommended CIBT to assist you in applying for your India tourist visa(s). Please ensure you read the following information thoroughly and submit this form when returning your application.

DEADLINE: Documents must be received by CIBT **no earlier than 3 months** prior to entering India but no later than 20 calendar days prior to the date you require your passport(s) back. Should you be unable to meet this deadline please contact CIBT before sending your application to ensure that there is sufficient time for processing. Late submission fees of up to £30 per person may apply.

**REQUIREMENTS FOR BRITISH CITIZENS ONLY**

Please send the following documents (per applicant):

- British Citizen Passport. It must have 6 months validity beyond the completion of your trip. It must be in **tidy** condition and have at least **one blank page**.
- One completed Indian application form, signed and dated. Please complete in capitals in black ink (please answer all questions). You must supply the contact details of two people that will be in the UK whilst you are in India (relatives, next of kin, friends, neighbours etc) . The referee in India is 'British High Commission, New Delhi, India' (one will suffice).
- Two passport-type photographs. They must be in **colour** on a plain background.
- Completed** Client Form for CIBT (**overleaf**).
- Payment** for visa application (See note below).
